5.2 Special hazards arising from the substance or mixture

Hazards from the substance or mixture

: Flammable liquid and vapor. Fire will produce dense black smoke. Exposure to decomposition products may cause a health hazard. The vapor/gas is heavier than air and will spread along the ground. 7.1 Precautions for safe handling
